Who we are and what we do

The Municipal Court Administration Association offers training to court administrators, clerks of court, municipal judges and other city or town employees involved in court administration. The Association focuses on fostering and developing interest in sound court administration, encouraging the most advanced technologies in the field of court administration, and disseminating information to and exchanging ideas among its members. Membership levels and fees

Active Membership – \$65

Municipal court administrators or clerks of court only. An active member has voting member status.

Additional Active Membership – \$5

An individual from the same municipal court (excluding judges and law enforcement personnel) interested in the principles and practices of court administration. A municipal court administrator or clerk of court must be identified as an active member before purchasing additional memberships. Additional active members have voting member status.

Associate Membership – \$30

Judges, law enforcement or other municipal personnel interested in the principles and practices of court administration. Judges, magistrates or other county personnel are only eligible for this membership level. Associate members do not have voting member status.

Vendor Membership – \$150

Any private company or individual who provides court administration products, services or information to municipalities. Vendor members do not have voting member status.
