Municipal Membership – fee is population-based

An employee or elected official of a municipality engaged in the operations and management of information technology within the municipality represented

Additional Active Membership – \$20

An individual from the same municipality who is involved in the practice of information technology

Associate Membership – \$55

An individual not eligible for municipal membership status that is interested in the principles and practices of information technology and does not directly or indirectly market products, services or information to municipalities

Vendor Membership – \$130

An individual who is interested in the principles and practices of information technology and is actively engaged in marketing products, services and/or information to municipalities
