Build Relationships

- Say thank you before you say please
- Find something in common
- Stay in contact through calls, email and meetings
- Visit your legislator in Columbia for no reason
- Invite your legislators to City Hall



Know your information

- Be ready with anecdotal information and stories that illustrate your position
- Back that story up with numbers, figures and percentages
- Give your opinion in a nice, respectful way

Stay on message

- Stay focused on the topic
- Don't veer off with other problems
- Don't be afraid to ask for a yes or no
- Always come with a positive solution rather than only a negative complaint



Time it right

- Schedule a face to face meeting
- Be ready to give your whole argument in 3 minutes or less (even if you have charts and graphs) while walking
- 10 other people need your legislator's time as bad as you do
- Be precise, to the point and kind
