All tax rates are subject to change based upon changes in city and state laws.

Check-in time is 3:00 PM, check-out time is 11:00 AM. All guests arriving before 3:00 PM will be accommodated as rooms become available. The Front Desk can arrange to check baggage for those arriving before 3:00 PM when rooms are unavailable and for guests attending functions on departure day.

These discounted rates for the event are extended as a courtesy, on a rate availability basis, and the hotel is guaranteeing no specific block of guest rooms.

The hotel reserves the right to discontinue the courtesy rate at such a time that we are projecting to sell out over the program dates. The hotel will notify us in advance if and when occupancies should dictate that they can no longer accept the courtesy discount rate.

FROM THE HOTEL:

In the event a guest checks out before the guests' reserved check-out date, the Hotel will add an early check-out fee of \$50.00 to that guest's individual account. Guests wishing to avoid an early check-out fee should advise the Crowne Plaza North Augusta at or before check-in of any changes in planned length of stay. The Crowne Plaza North Augusta will inform your attendees of this potential change upon check-in and request that you inform your attendees of the same obligation.

The Crowne Plaza North Augusta is a non-smoking hotel. The non-smoking policy applies to all guest rooms, suites, outlets and public areas. Smoking is not permitted within the hotel building, and guests who smoke are permitted to do so in designated areas. There is a significant room deep cleaning charge

of two hundred fifty dollars (\$250.00) minimum for guests who do not comply. This deep cleaning fee will be charged to the guest account of the individual(s) that violate this policy to cover the extensive cost of restoring guest rooms to a smoke-free condition.

Cancellation of confirmed reservations must be made 72 hours prior to arrival. A Cancellation Fee of one night's room rate and tax will be charged to the group master account or individual guest's credit card for any cancellations made within 72 hours prior to arrival.

Per Hotel policy, outside food & beverage, are not permitted on hotel premises for consumption within the Hotel banquet spaces, hospitality suites, or public areas.

The Crowne Plaza North Augusta offers 2 parking options, with associated restrictions and fees. Paid parking signage is posted at the entrance of Riverside Village at Railroad Street, Center Street, and Front Street.

Street Parking is accepted at 21 meters posted throughout the area with coin or card at the meter.

Garage parking is available in both short and long-term parking in the Hotel Covered Parking garage.

Current parking rates are as follows:

- First 2 hours are free.
- 3rd hour and beyond - Fees are assessed at \$1.00/hour with a maximum rate of \$10.00/day.
Please be advised parking rates are not set out by the Hotel and are subject to change at the discretion of the City of North Augusta.
