Who we are and what we do

Membership levels and fees

Active Membership – \$50

Any individual with professional or paraprofessional responsibilities (e.g., human resources director) whose essential employment functions are devoted to personnel administration for an entire municipality or other municipal entity, including councils of governments and commissions or departments of public works. An active member has voting member status.

Additional Active Membership – \$10

An individual from the same municipality or other municipal entity as an existing member who is involved in the practice of human resources (e.g., human resources staff other than director, payroll clerk, etc.). Additional active members have voting member status.

Associate Membership – \$25

Any private company, county government official or individual who is not eligible for active membership but is interested in the principles and practices of governmental human resources management. Associate members do not have voting member status.
