INTRODUCTION

The South Carolina Judicial Branch's Office of Court Administration provides this information in an effort to improve access to justice for those who have Limited English Proficiency or are deaf or hard of hearing.

The South Carolina Court Interpreter Directory contains the names and contact information for spoken foreign language court interpreters who have completed the South Carolina Court Interpreters Certification Program (SCCICP) to become certified or deemed otherwise qualified to provide interpreting services in South Carolina courts. Also included in this directory is the name and contact information for sign language interpreters.

This information is provided to the clerks of court to help them to efficiently schedule court interpreter coverage for court proceedings in their counties. For attorneys and members of the public, who have an upcoming court hearing, the request for a court interpreter for that hearing should be sent to the clerk of court in the county where the case is filed, or – if the case is before a Summary or Municipal Court – sent to that court. The appointment of a court interpreter is by written order of the Court. The fact that an interpreter is listed in this directory does not indicate an employment relationship with the South Carolina Judicial Branch.

It is important to note when using a court interpreter for court proceedings, that mileage is normally paid for one round trip per day and mileage will be reimbursed only when interpreter travels outside of their county of residence or business headquarters. Interpreters who travel for two separate interpreting sessions when there is more than three (3) hours between those two sessions, will be paid mileage for both sessions. The South Carolina Judicial Branch will pay up to the approved rate. If the court interpreter charges more than the approved rate, it is up to the clerk of court and the court interpreter to agree to payment of the portion of the rate that exceeds the approved rate. The clerk of court will be responsible for paying the remaining balance, thus it is important to coordinate a court interpreter with the clerk of court. Please see the Policy & Procedure Guide for more information on rates.

For matters requiring a court interpreter located out of state, the clerk is responsible for costs greater than those allowed in the Court Interpreter Policy and Procedure Guide. For those hearings, requiring an out-of-state court interpreter, telephonic/remote interpretation should be used when appropriate. Prior to engaging the out-of-state court interpreter, the clerk must discuss the rate the interpreter charges as well as the accepted method of payment directly with

the court interpreter. Any costs above those outlined in the Court Interpreter Policy and Procedure Guide will not be reimbursed by Court Administration.

Though we work diligently to keep the directory up to date, it is the responsibility of the court interpreters listed in the directory to keep us informed of any changes to their contact information.

The directory will be reviewed on an ongoing basis and discrepancies will be corrected as they are identified.

Foreign languages are arranged alphabetically in the directory. Interpreters are also listed alphabetically within that section by name and contact information. We have also provided information, which allows you to tell at a glance whether the interpreter is certified or otherwise-qualified and what dialect, if any, they are able to interpret. Most certified interpreters have been certified in other states. The otherwise-qualified interpreters have successfully completed at least two phases of the S.C. Certification Program.

Information detailing the program is on the next page. By reviewing this section, you will understand the phases of the program and why you are being required to use only the interpreters that are listed in this Directory.

Sign language interpreters are listed in the specific section of the directory. Spanish language interpreters are the most frequently requested in our courts. For your convenience, they are arranged alphabetically in the next section by county.

SOUTH CAROLINA COURT INTERPRETER CERTIFICATION PROGRAM

The court interpreter is a specially trained professional who possesses a variety of skills that distinguish him or her from bilingual persons who simply speak two languages. The interpreter plays a vital role in facilitating communication within the judicial system for the non-English speaker and ensures due process by putting the non-English speaker on the same footing as the person who understands English. It is much more than being bilingual. Court interpreters must be able to do sight translation, simultaneous and consecutive interpreting. Summarizing, paraphrasing, changing or omitting is not acceptable.

Certification is a three-phase process and includes participation in a two-day workshop, successfully passing the written exam (80% or greater), and passing an oral certification exam (70% or greater on each of the components).

- a. **Two-Day Workshop:** Topics include Rules of Professional Conduct for Court Interpreters, court interpreting modes and skills, justice system structure and procedure, legal terminology, and self-study aids and techniques to improve one's skills. This is a mandatory workshop that must be attended in addition to the Written and Oral Tests.
- b. **Written Test:** This three-hour test includes general English proficiency, legal terminology and professional ethics. Candidates must receive 80 percent or greater on this written test to achieve a passing grade. This phase of the program should be taken in order to assess your English proficiency and ability to interpret in a court setting.
- c. **Oral Proficiency Test:** This test simulates what a court interpreter will be expected to do in court. It has three parts: sight translation of documents from English to the target language and to English from the source language; consecutive interpretation of testimony in both the target and source languages; and simultaneous interpreting of English into the target language. A candidate must score at least 70 percent on each portion of the test to receive certification.
