THE COURT INTERPRETER DIRECTORY IS PREPARED BY COURT ADMINISTRATION TO PROVIDE A CENTRALIZED LIST OF CERTIFIED OR OTHERWISE QUALIFIED INTERPRETERS FOR THE COURTS, AND IS FOR INTERNAL USE ONLY.

THE DIRECTORY SHOULD NOT BE SHARED WITH ATTORNEYS, PARTIES, OR OTHERS THAT ARE NOT WORKING FOR THE COURT.

ALL INTERPRETERS FOR COURT PROCEEDINGS SHOULD BE SCHEDULED BY THE CLERK OF COURT OR COURT ADMINISTRATION, NOT BY ANY PARTIES INVOLVED.



INTRODUCTION

The South Carolina Judicial Branch’s Office of Court Administration (Court Administration) provides this information in an effort to improve access to justice for those who have Limited English Proficiency or are deaf or hard of hearing by compiling a resource to be used by the clerks of court when locating interpreter resources for court proceedings.

The South Carolina Court Interpreter Directory (Directory) contains the names and contact information for freelance spoken foreign language court interpreters who have completed the South Carolina Court Interpreters Certification Program (SCCICP) and have met the requirements to be deemed certified or otherwise qualified to provide interpreting services in South Carolina courts. Also included in the Directory are the names and contact information for certified sign language interpreters.

The information contained in the Directory is provided to the clerks of court to help them to efficiently schedule freelance court interpreter coverage for court proceedings in their counties. For attorneys and members of the public, who have an upcoming court hearing requiring an interpreter, the request for a court interpreter for that hearing should be sent to the clerk of court in the county where the case is filed, or – if the case is before a Summary or Municipal Court – sent to that court. The appointment of a court interpreter is by written order of the Court, which is found on the SCCA Form 261 – Request for Court Interpreter. The fact that an interpreter is listed in the Directory does not indicate an employment relationship with the South Carolina Judicial Branch.

In conjunction with using the Directory, it is important to consult the Court Interpreter Policy and Procedure Guide (Guide) when using a freelance court interpreter for court proceedings. Important information regarding the governing rules and Orders of the Court, mileage guidelines, and reimbursement rates are contained within the Guide.

The Directory will be reviewed on an ongoing basis and discrepancies will be corrected as they are identified. Though we work diligently to keep the Directory up to date, it is the responsibility of the freelance court interpreters listed to keep us informed of any changes to their contact information.

HOW TO USE THE DIRECTORY

The first section of the Directory lists the foreign languages alphabetically with each applicable freelance court interpreters also listed alphabetically. In addition to the interpreters’ contact information, we have also provided information, which allows you to tell at a glance whether the interpreter is certified or otherwise-qualified and in which dialect, if any, they are able to interpret.



The second section of the Directory lists the sign language interpreters. Because Spanish language interpreters are the most frequently requested in our courts, the third section has the Spanish language interpreters listed alphabetically by county for ease of use.

HOW DOES AN INTERPRETER BECOME CERTIFIED OR DEEMED OTHERWISE QUALIFIED

The court interpreter is a specially trained professional who possesses a variety of skills that distinguish him or her from bilingual persons who simply speak two languages. The interpreter plays a vital role in facilitating communication within the judicial system for the non-English speaker and ensures due process by putting the non-English speaker on the same footing as the person who understands English. It is much more than being bilingual. Court interpreters must be able to do sight translation, simultaneous and consecutive interpreting. Summarizing, paraphrasing, changing or omitting is not acceptable.

The South Carolina Court Interpreter Certification Program is comprised of a robust multi-phase process that includes participation in a two-day workshop; successfully passing the written exam (80% or greater); earning an advanced rating in an Oral Proficiency Assessment or Interview; and passing an oral certification exam (70% or greater on each of the components).

- a. **Two-Day Workshop:** Topics include Rules of Professional Conduct for Court Interpreters, court interpreting modes and skills, justice system structure and procedure, legal terminology, and self-study aids and techniques to improve one's skills. This is a mandatory workshop that must be attended in addition to the Written and Oral Tests.
- b. **Written Test:** This three-hour test includes general English proficiency, legal terminology and professional ethics. Candidates must receive 80 percent or greater on this written test to achieve a passing grade. This phase of the program should be taken in order to assess your English proficiency and ability to interpret in a court setting.
- c. **Oral Proficiency Assessment or Interview:** The Assessment or Interview is designed to assess the candidate's proficiency in the target language, as well as their court readiness. This phase does not replace the oral certification exam.
- d. **Oral Certification Exam:** This test simulates what a court interpreter will be expected to do in court. It has three parts: sight translation of documents from English to the target language and to English from the source language; consecutive interpretation of testimony in both the target and source languages; and simultaneous interpreting of English into the target language. A candidate must score at least 70 percent on each portion of the test to receive certification.

Please note: Before contacting an interpreter, please find out the country of origin the person who needs an interpreter is from (i.e. Egypt, Mexico, Spain, etc.) and what language they speak, as there may be several languages and/or dialects spoken in that country. An interpreter may be familiar with some dialects, but not with others.
