The National Pollutant Discharge Elimination System Permit for Stormwater Discharges from Construction Activities is in the process of being reauthorized. This Construction General Permit authorizes stormwater discharges from large and small construction activities where those discharges enter Surface Waters of the State, or a Municipal Separate Storm Sewer System leading to Surface Waters of the State subject to the conditions set forth in this permit. This permit also authorizes stormwater discharges from any other construction activity designated by SCDES where SCDES makes that designation based on the potential for contribution to a violation of a Water Quality Standard or for significant contribution of pollutants to Surface Waters of the State.

11:10 a.m. – noon Trenchless Stormwater Pipe Repair in a City of Columbia Subdivision

North Tanglewood is a small subdivision which was initially built in the City of Columbia in the 1940s.

The stormwater pipes in the subdivision are predominantly reinforced concrete pipe, and partially maintained by the SC Department of Transportation in addition to the city-maintained portion. The stormwater infrastructure is deteriorating, and has resulted in several sinkholes and other concerns for the residents. Modeling of the system determined that stormwater capacity was not an issue. To minimize cost and digging up established yards, the city decided to pursue a largely trenchless pipe-lining option. A cured-in-place-pipe lining is planned for a majority of the pipes, with a geopolymer spray liner where needed due to large and shallow pipes. Hear about the pros and cons of trenchless stormwater pipe repairs and the various challenges encountered during this project.
